**The Afterlife Convention
Exhibitor Contract
Terms and Conditions**

General

"AC" hereafter shall mean the Afterlife Convention, a California Limited Liability Company and the festival events that will be conducted on September 28, 2013 in Santa Monica during the day. AC shall have the power to interpret and enforce these terms and conditions governing exhibitors. All matters and questions not covered by these terms and conditions shall be subject to the final judgment and decision of AC. This exhibitor contract, when properly executed, shall be a binding agreement between the two parties.

Applications and Eligibility

Application for table space must be made on this contract. AC reserves the right to determine the eligibility of any exhibit for inclusion in the book festival event. The acceptance of a table does not carry AC 's endorsement of the exhibitor's books, merchandise or service. AC reserves the right to require the modification or removal of any exhibit that, in its opinion, is not in character with the event.

Agreement to Conditions

Each exhibitor, for itself and its employees, agrees to abide by these terms and conditions and agrees that the sole control of the event rests with the AC.

Assignment of Space

Each exhibitor, for itself and its employees, agrees to abide by these terms and conditions and agrees that the sole control of the event rests with the AC.

Table Equipment and Electricity

AC will provide tables subject to availability and AC discretion. Each area will consist of a 6x2 foot table, two chairs and linen. There is no electricity available.

Care of Exhibit Space

Exhibitors are expected to keep their table space in good order. Exhibitors may not place anything in the area outside their table during festival hours.

Setup time will be in the morning of Saturday, Sept. 28, time TBD. Exhibitors will maintain and operate tables between 11 a.m. and 5 p.m. on Saturday Sept. 28, 2013. The exhibitor will remove all contents of tables no earlier than 5 p.m. and no later than 6 p.m. on Saturday, Sept. 28, 2013.

Subletting of Space

The exhibitor may not assign or sublet any space allotted to it and may not advertise or display goods other than those sold by them in the regular course of business. The space assigned to the exhibitor is for its own exclusive use and may be used only for the display and sale of its goods and services.

Cancellation and Refund Policy

All cancellations must be made in writing to the AC at bruce@afterlifeconvention.com No refunds whatsoever will be made.

Liability

The exhibitor shall at all times protect, indemnify, save and keep harmless AC from any damage, liability, or expense arising from or out of any loss or injury to any property or person, including the exhibitor, its agents, employees, and business invitees, which arise from or out of or by reason of the exhibitor's occupancy and use the exhibition premises or a part thereof. The exhibitor is encouraged to insure itself against property loss or damage and against liability for personal injury at its own expense

Book Sales

You are responsible for collecting and remitting all sales tax to the federal, state and city officials. We requires a complete list of what you will sell by Sept. 15, 2013 and reserve the right to exclude items.
